### HAMILTON TO WILLS.

THIS INDENTURE Made this 1st day of August 1914 between Maggie E. Hamilton and E.C. Hamilton, her husband, parties of the first part, and P.S.C. Wills, party of the second part, witnesseth;

That for and in consideration of the sum of one dollar, and the consideration for former deed dated December 26th 1912, and recorded December 28th 1912 in Book 0 of Deeds at page 167 for correction of which this conveyance is given, the parties of the first part do hereby grant, bargain sell and convey unto the said party of the first part the following premises in Skamania County, Washington, towit: Beginning at a point which is 30 feet south of the southeast corner of lot numbered nine in block numbered 3 of Hamiltons' Addition to the Town of Underwood Washington, according to the official plat thereof on file and of record in the office of the County Auditor of Skamania County Washington at page 39 of Plat Book A, thence north 30 feet to the southeast corner of said Lot nine Block 3, thence northerly along the south line of said block three 250 feet more or less to the westerly line of the county road (known also as Main Street) thence Southerly along the westerly line of said county road to the intersection thereof with the south line of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  sec 23 tp 3 N.R.10 E. of W.M., thence west to the place of beginning.
