

AND TO PAY ALL TAXES AND ASSESSMENTS THEREON AND UPON THIS MORTGAGE, AGAINST LOSS BY FIRE, AND FAILURE TO PAY SAID TAXES AND ASSESSMENTS SHALL ENTITLE MORTGAGEE TO PAY SAME AND INCLUDE SUCH PAYMENTS IN THE AMOUNT SECURED BY THIS MORTGAGE AND DRAW INTEREST ACCORDINGLY FROM DATE OF SUCH PAYMENT.

NOW THEREFORE, IF THE COVENANTS HEREIN SHALL BE PERFORMED AS AGREED THIS CONVEYANCE SHALL BE VOID; BUT IN CASE DEFAULT SHALL BE MADE IN THE PAYMENT OF THE PRINCIPAL OR INTEREST WHEN EITHER PRINCIPAL OR INTEREST SHALL BECOME DUE, OR IN ANY COVENANT HEREIN, THEN THE WHOLE SUM SHALL IMMEDIATELY BECOME DUE AND PAYABLE AND THE MORTGAGEE, OR HIS LEGAL REPRESENTATIVES MAY FORECLOSE THIS MORTGAGE AT ANY TIME THEREAFTER.

AND IT IS FURTHER AGREED THAT IF THE MORTGAGEE OR HIS LEGAL REPRESENTATIVES ARE COMPELLED TO FORECLOSE THIS MORTGAGE BY REASON OF THE NON-PAYMENT OF THE SAID NOTE OR ANY PORTION THEREOF, THEN IN ADDITION TO THE SUM FOUND DUE AT THE TIME OF THE FORECLOSURE, SHALL BE ENTITLED TO RECOVER SUCH SUM AS THE COURT MAY ADJUDGE REASONABLE AS ATTORNEY'S FEES IN SAID SUIT IN ADDITION TO COSTS AND DISBURSEMENTS ALLOWED BY THE CODE OF CIVIL PROCEDURE, THE COURT MAKING THE DECREE OF FORECLOSURE IS AUTHORIZED TO INCLUDE IN SUCH DECREE THE SUM AFORESAID UPON DEMAND OF PLAINTIFF IN SAID FORECLOSURE SUIT.
