THIS INDENTURE WITNESSETH, That Haktor Aalvik an unmarried man, of Stevenson, Washington party of the first part, for and in consideration of the sum of Ten (\$10.00) Dollars in lawful money of the United States of America to him in hand paid by John M.Skaalheim of Stevenson, Washington, party of the second part, has GRANTED, BARGAINED AND SOLD, and by these presents does Grant, Bargain, Sell, and Convey unto the said party of the second part his heirs and assigns, the following described real property, situate, lying and being in the County of Skamania, State of Washington, to-wit:
An undivided one half ($\frac{1}{2}$) interest in and to Lots numbered Three (3) and Four (4) in Block numbered Five (5) of Upper Cascades Addition to the Town of Stevenson as shown by the official plat of said Addition now on file and of record in the office of the Auditor of said Skamania County, Washington.
