The said pole line to be and remain where now constructed.

FRAINE TO SCHOOL DISTRICT NO. 27

THIS INDENTURE, Made this 29th day of June in the year of our Lord one thousand nine hundred and fourteen, BETWEEN W.M. Fraine, a single man the party of the first part, and School District No. 27 of Skamania County, Washington party of the second part:

208 feet square containing one acre more or less situated in the S.E. corner of the S.W. 1/4 Sec. 18 T 3 N R 10 E.W.M. together with the right to lay water pipes from the spring on said quarter section to the school house said pipe line to be placed below the plow line.
