between the parties hereto dated J_{une} 22nd, 1912, reference to which is hereby made as though the same were herein fully incorporated.

In the event of the construction of said transmission lines within the time above mentioned, pursuant to authority hereby granted over the premises last above described, said Electric Company shall abandon said transmission lines as constructed over the premises first hereinabove described and marked in yellow upon the blue print hereunto attached and shall forthwith remove therefrom all of its property constructed upon said first above described premises, and shall re-convey said premises to the Power Company.

This indenture shall be binding upon the parties hereto, their respective successors and assigns.
