Hall, his heifs and assigns, all the following bounded and described real property, situated in the County of Skamania, State of Washington, to wit:

The Northeast quarter of Section Thirty-two (32) in Township Two (2) North of Range Five (5) East of Willamette Meridian, containing 160 acres, more or less, together with all and singular the tenements, hereditaments and appurtenences thereto belonging or in anywise appertaining, and also all their estate, right, title and interest in and to the same, including dower and claim of dower.

To Have and to Hold, the above described and granted premises unto the said Elijah O.Hall his heirs and assigns forever. And Ella L.
