THIS INDENTURE, MADE THIS 1ST DAY OF NOVEMBER A.D. 1921 BY AND BETWEEN JOHN B. GLOVER AND LAURA D. GLOVER, HIS WIFE PARTIES OF THE FIRST PART, AND CAROLINE EVERDING PARTY OF THE SECOND PART.

WITNESSETH, THAT WHEREAS, THE PARTY OF THE SECOND PART HAS LOANED TO THE PARTIES OF THE FIRST PART THE FULL SUM OF THREE THOUSAND AND NO/100 DOLLARS, WHICH SUM THE SAID PARTIES OF THE FIRST PART AGREE TO REPAIR ON OR BEFORE THREE YEARS AFTER THIS DATE, AND TO PAY INTEREST THEREON SEMI-ANNUALLY AT THE RATE OF 6-1/2 PER CENT. PER ANNUM FROM THIS DATE UNTIL PAID; AND ALSO TO PAY ALL TAXES AND ASSESSMENTS WHICH MAY BE ASSESSED OR LEVIED TO OR AGAINST THE PART.. OF THE SECOND PART OR ASSIGNS, ON ACCOUNT OF SUCH LOAN.
