THIS INDENTURE WITNESSETH, THAT FRED WISE PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF SEVEN HUNDRED AND NO/100 DOLLARS, TO HIM IN PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS BARGAINED, SOLD AND CONVEYED AND BY THESE PRESENTS DOES BARGAIN, SELL AND CONVEY UNTO JAS. H. MCMENAMIN AND JOHN COLLIER PARTIES OF THE SECOND PART, THE FOLLOWING DESCRIBED PREMISES, TO-WIT:
