Commencing at a point on the south line of the north half of the Henry Shepard D.L.C. where said line intersects the south line of the right of way of the S.P. & S.Ry company in sec 36 tp 3 N.R. 7½ E. of W.M., thence east to a point 218 feet west of the southeast corner of the Monroe Vallett farm, as described in deed executed by A.W. Lambert and wife and recorded in Book G of Deeds at page 483 records of Skamania County, Washington, thence, in a northerly direction to a point which is on the said south line of said right of way distant 154 feet westerly from the intersection thereof with the east line of the Monroe Vallett farm before mentioned (said distance being measured along said south line of said right of way), thence following said south line of said right of way westerly to the place of beginning; reserving, however, an easment for a road along the south line of the above conveyed tract where the present old road is now located.
