WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Two Dollars, lawful money of the United States of America to us in hand paid by the said parties of the second part, does by these presents, remise, release, convey and quitclaim, unto the said parties of the second part, thier heirs, executors, administrators and assigns, all interest of the parties of the first part in the following described real estate, lying and being in the County of Skamania, State of Washington, to-wit:

Commencing at this discovery post being the center of the vein and upon which this notice is posted thence 1500 feet northerly to a post marked No. one, North center end thence 300 feet Easterly to a post marked No. 2, N. East corner, thence 1500 feet southerly to a post marked No. 3 S. East corner; thence 300 feet westerly to a post marked No. 4 S. center end; thence 300 feet westerly to a post marked No. 5, S. West corner; thence 1500 feet northerly to a post marked No. 6, North west corner thence 300 feet easterly to North center end. This claim is located at the base of Bismark Mountain on the south slope and is designated and known as Copper Crown No. 2, Mining claim.
