Parties of the first part, and the Commonwealth Milling, Mining and Smelting Company the parties of the second part

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Two Dollars, lawful money of the United States of America to us in hand paid by the said parties of the second part, does by these presents, remise, release, convey and quitclaim, unto the said parties of the second part, their heirs, executors, administrators and assigns, all interest of the parties of the first part in the following described three mining claims lying and being in the County of Skamania, State of Washington, to-wit:

These claims are located in Section 4, Township 9, North Range, 6 East, Willamette Meridian, Washington, Texas Lode No.1, beginning on North Fork Lewis river running in a northerly direction 1500 feet and 600 hundred feet in width and joined on the north by Texas Lode No.2 Texas Lode N2, boundry south by the north line of Texas Lode No.1, running northerly 1500 feet and 600 feet wide easterly and westerly, boundry north on the south line of Texas Lode No.3, Texas Lode No.3, south line beginning on the North line of Texas Lode No.2, running northerly 1500 feet 600 feet easterly and westerly, bounded at the north line, on the south line of Copper Crown Lode all three of these forgoing described properties are on the same vein as Lode known as (The Copper Crown Lode).
