KNOW ALL MEN BY THESE PRESENTS, That we N.A. Rodlun and Lura A. Rodlun husband and wife, of Forest Grove <sup>in the State of</sup> Oregon, in consideration of One and more Dollars and other value to us paid by Ole N. Rodlun unmarried of Boring in the State of Oregon do hereby grant, bargain, sell and convey unto the said Ole N. Rodlun also known and designated as O.N. Rodlun his heirs and assigns, all the following bounded and described real property situated in the County of Skamania and State of Washington, to-wit:

The south-east quarter of the northwest quarter (SE $\frac{1}{4}$  of NW $\frac{1}{4}$ ) and Gov. lots three (3) four (4) and five (5) Section six (6) Township three (3) north range nine (9) East of W.M. containing 157.63 acres according to the U.S. Gov. survey.

TO HAVE AND TO HOLD the above granted premises, with all the rights, easements, and appurtenances thereto belonging, unto the said Ole N. Rodlun his heirs and assigns forever. And we the said grantors do covenant to and with the said grantee his heirs and assigns that we are lawfully seized in fee of the above granted premises; that the said premises are free from all encumbrances, except a first mortgage for \$500. a second mortgage for \$500. and a third mortgage for \$130. and taxes with interest on said encumbrances and that we will and our heirs/and <sup>executors</sup> administrators shall warrant and defend the above granted premises, to the said grantee heirs and assigns forever against the lawful claims and demands of all persons except said mortgages and taxes, in satisfaction of which this deed is given.
