LOWDEN TO UNDERWOOD IRRIGATION DISTRICT

KNOW ALL MEN BY THESE PRESENTS: That I, Gladys Lillian Lowden, Executrix of the Estate of John M. Lowden, in consideration of the sum of One (\$1.00) Dollar in hand received, and other good and valuable considerations, do hereby bargain, sell and grant unto Underwood Irrigation District, an irrigation district of Skamania County, Washington, an easement over and through a right of way extending across the North side of the grantor's land in the Northwest quarter (NW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section Twenty-Two (22), Township Three (3), North, Range Ten (10), East of Williamette Meridian.

The above easement is granted for the purpose of and is to be used by said grantee District for a canal, flume or pipe line in which to convey water for irrigating the lands within the District through the District's irrigating system; and shall be of sufficient width to allow for the construction and maintainance of such canal, flume or pipe line, and to repair, rebuild and repair the same.

TO HAVE AND TO HOLD the same unto the said Underwood Irrigation District, its successors and assigns, forever.
