

of other good and valuable considerations, do hereby bargain, sell and grant unto Underwood Irrigation district, and irrigations district of Skamania County, Washington an easement over and through a right of way extending across the North side of the grantor's land in the Northwest quarter (NW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section Twenty-two (22), Township three (3), North, Range Ten (10), East of Willamette Meridian.

The above easement is granted for the purpose of and is to be used by said grantee District for a canal, flume or pipeline in which to convey water for irrigating the lands within the District through the District's irrigating system; and shall be of sufficient width to allow for the construction and maintainance of such canal, flume or pipe line, and to repair, rebuild and replace the same.

TO HAVE AND TO HOLD the same unto the said Underwood Irrigation District, its successors and assigns, forever.
