

## BOWLES-BOWLES.

KNOW ALL MEN BY THESE PRESENTS: That I, J.R. Bowles, of the City of Portland, County of Multnomah, State of Oregon, in consideration of the sum of one dollar and other valuable considerations to me paid by Bernice C. Bowles (wife of J.R. Bowles) of the City of Portland, do hereby release, remise and forever QUITCLAIM unto the said Bernice C. Bowles, and unto her heirs and assigns, all my right, title and interest in and to the following described parcel of real estate, situate in Skamania County, State of Washington, to wit:-

1. Lot<sup>105</sup> numbered one (1) and two (2), and the northwest quarter of the northeast quarter of section ten (10), and lot numbered seven (7) and the southwest quarter of section three (3), in township two (2) north, range seven (7) east of the Willamette Meridian, containing one-hundred and fifty-one acres and sixty-six hundredths of an acre;
2. Lot numbered five (5) and the southwest quarter of the southwest quarter of section two (2), township two (2) north of range seven (7) east of the Willamette Meridian, containing fifty and twenty hundredths acres; more or less;
3. Lot five (5) of section eleven (11), in township two (2) north, range seven (7) east of the Willamette Meridian, containing forty-two and twentyfour hundredths acres more or less;
4. Beginning at a point in the west boundary of the Bradford D.L.C. No. 37, one hundred seventy-five (175) feet, more or less, southerly from the quarter corner between section ten (10) and eleven (11), in township two (2) north, range seven (7) east of the Willamette Meridian, and running north of east following the center line of State Road No. 8 as located and now being constructed to the center of Mill or Bowles Creek, thence northwesterly along the center of said creek to the northwesterly boundary of said D.L.C.; thence westerly along the north boundary of said Bradford D.L.C. to the northwest corner of said claim, <sup>thence southerly along the west boundary of the claim</sup> to the point of beginning, containing twenty-three acres, more or less, situate in section eleven (11), in township two (2) north, range seven (7) east of the Willamette Meridian.

TO HAVE AND TO HOLD the same, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining, to the said Bernice C. Bowles, and to her heirs and assigns forever.
