MARTELLI... .. MARTELLI:

THIS INDENTURE, made this 6th day of August, 1917 between Domenico Martelli of Cape Horn, Washington, party of the first part, and Mary Martelli, the wife of said Domenico Martelli, party of the second part, witnesseth:

That the said party of the first part, for and in consideration of the love and affection which he bears towards his wife, the said Mary Martelli, and for the purposes of compensating her for the care and attention she has given to the grantor and which she shall hereafter continue to give to said grantor, does hereby give grant, alien, and convey, unto his wife, said party of the second part, and undivided one half interest of the said grantors interest in and to the NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION THREE IN TOWNSHIP ONE NORTH OF RANGE FIVE EAST OF WILLAMETTE MERIDIAN, in Skamania County, Washington.

To have and to hold the same unto the said party of the second part, her heirs and assigns, for her own sole and separate use, benefit, and behoof forever, subject to any debts or claims against said property which may appear by the future probate of the estate of Mary Martelli deceased, the former wife of said grantor herein.

To hold and enjoy the same, as and for her separate estate especially relinquishing for himself and his heirs all right or claim to the same, or any part thereof as community property, so that the same may be held by her as separate, and not in any respect as community property.
