This memorandum of an agreement Witnesseth: That for and in consideration of the sum of One Dollar, receipt of which is hereby acknowledged, we, Lars Anderson and Louise Anderson his wife, hereby give and grant to Erick Larsen and Nels Erickson, the right to construct and maintain head gates, ditch and flume on and across the land described as the NW 1/4 of Section 14, Tp. 3, N. of Range 8 E. W. M. in Skamania County, Washington, as now located and as heretofore agreed on between the parties hereto, and to divert such water as may be necessary to operate said flume and ditch from Little Wind River at said Head Gates for use on land of said Erick Larsen, in the SW 1/4 of said Section 14, Tp. 3, N. R. 8, E. W. M.
