The East Half of the Northwest quarter of Section Twenty four (S.E. $\frac{1}{4}$ N.W. $\frac{1}{4}$ Sec. 24) in Tp. 3 North, Range 7 E. WilpMer.

TO HAVE AND TO HOLD, the said premises, with all their appurtenances, unto the said party of the second part and to his heirs and assigns forever; and the said Frank Baldwin and Henrietta J. Baldwin parties of the first part, for them and for their heirs, executors and administrators, do hereby covenant to and with the said party of the second part his heirs and assigns that they are the owners in fee simple of said premises, and that they are free from all incumbrances except a certain mortgage of \$1000.00 executed by Frank Baldwin and Henrietta J.
