COX TO THE PUBLIC.

I, Sarah A.Cox, wife of Revd. Samuel Cox, D.D., of Garden City, in the County of Queens and State of New York do hereby make, publish and declare this to be my last Will and Testament, intending hereby to dispose of all the property, both real and personal of which I may have the right or power to dispose at the time of my death.

FIRST; I direct that all my just debts and funeral expenses be paid as soon after my death as may be practicable.

SECOND: I give and bequeath all my clothing, Jewelry and/silverware to my sister Eliza J.Leverich and my niece Daisy Leverich in equal shares.

THIRD: I give, devise and bequeath one equal fourth part of all the rest, residue and remainder of my estate, both real and personal, to my beloved husband, Samuel Cox, for and during the term of his natural life; and upon the death of my said husband, I direct that the said one fourth part of my residuary estate be divided into three equal shares; one of said shares I give, devise and bequeath to my niece Daisy Leverich; one of said shares I give devise and bequeath to my niece, Louise Leverich; and one of said shares I give devise and bequeath to the children then living of my niece, Adele Villars, wife of Albert Villars, of New Orleans, in the State of Louisiana.

FOURTH. I give, devise and bequeath one equal fourth part of my said residuary estate to my Executor hereinafter named, in Trust, to receive the rents, issues and profits thereof, and to pay over the same to my beloved sister, Eliza J. Leverich for and during the term of her natural life, and upon the death of my said sister, I direct that the said one fourth part of my residuary estate be divided into three equal shares, one of said shares I give, devise and bequeath to my niece, Daisy Leverich; one of said shares I give, devise and bequeath to my niece Louise Leverich and one of said shares I give, devise and bequeath to the children then living of my
