KNOW ALL MEN BY THESE PRESENTS THAT Edith Fraine Richards and V. M. Richards, her husband, of Boston, Massachusetts, the grantors, for and in consideration of One Hundred Eight Seven Dollars and fifty cents (\$187.50), in hand paid, bargain, sell and convey to Jacob A. Haak of Portland, Oregon, grantee, an undivided one-thirty-second interest and to George H. Marsh of Portland, Oregon, grantee, an undivided one-thirty-second interest in and to the following described land situated in the County of Skamania, State of Washington, to-wit:

All that part of Section Eighteen (18) Township Three (3) North of Range Ten (10) East of the Willamette Meridian, described by metes and bounds as follows: Beginning at a point on the Section Line between Sections Eighteen (18) and Seventeen (17) Township Three (3) North of Range Ten (10) East of the Willamette Meridian, Sixty-six and two-thirds ($66\frac{2}{3}$) rods South of the Northeast Corner of the Southeast Quarter ($SE\frac{1}{4}$) of Section Eighteen (18) Township Three (3) North of Range Ten (10) East of the Willamette Meridian; thence running West Three hundred and Twenty (320) rods to the Township line between Ranges Nine (9) and Ten (10) East of the Willamette Meridian; thence South on said Township line Ninety-three and one-third ($93\frac{1}{3}$) rods to the Southwest Corner of Section Eighteen (18), Township Three (3) North of Range Ten (10) East of the Willamette Meridian; thence East on the Section Line between sections Eighteen (18) and Nineteen (19) Township Three (3) North of Range Ten (10) East of the Willamette Meridian to the South East corner of said Section Eighteen (18) thence North Ninety-three and one-third ($93\frac{1}{3}$) rods on the section line between Sections Eighteen⁽¹⁸⁾ and Seventeen (17) Township Three (3) North of Range Ten (10) East of the Willamette Meridian to the Point of beginning containing One Hundred and Eighty-six and Two-thirds ($186\frac{2}{3}$) acres, more or less.
