SISCO of \_\_\_\_\_ State of Oregon, have bargained and sold and by these presents does grant, bargain, sell and convey unto said Frank M.Sisco their heirs and assigns, all the following bounded and described real property, situated in the county of Skamania and State of Washington, All of the north half of the north east quarter of the northeast quarter of section twenty four in township three (3) north of range eight (8) East of the Willamette Meridian containing twenty acres in Skamania County Washington, according to the Government survey thereof. together with all and singular the tenements hereditaments and appurtenances thereto belonging or in anywise appertaining and also all pur estate, right, title and interest in and to the same, including dower and claim of dower.

TO HAVE AND TO HOLD the above described and granted premises unto the said Frank W.Sisco \_\_\_\_\_ heirs and assigns forever.
