THIS INDENTURE, Made this 10th day of October A.D. 1917. between Flora Butler Travis the party of the first part and Lillie Gunther Miller the party of the second part: WITNESSETH, That the said party of the first part, for and in consideration of the sum of THREE HUNDRED THIRTY-THREE & thirty-three and 1/3 cents (\$333.33 1/3 Dollars lawful money of the United States of America, to her in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged does by these presents, remise, release and forever quit-claim unto the said party of the second part, and to her heirs, assigns, all-right all right title and interest in and to the following described tract of land being in the county of Skamania, State of Washington, particularly bounded and described as follows to-wit: The East half of the South East Quarter of Section three (3), in Township one (1) North of Range Five (5) East of the Willamette Meridian, containing eighty acres more or less. Also, the tract of land described as follows:
