(This deed is given to correct error in description of that certain deed recorded on page 591 of Book I of Deeds, Records of Skamania County, Washington.)

TO HAVE AND TO HOLD all and singular the aforesaid premises, together with the temements hereditaments and appurtenances thereunto belonging or in any wise appertaining, unto said second party his heirs and assigns forever.
