

SMITH to HOOD LAND CO.

THIS MEMORANDUM OF AN AGREEMENT, made and entered into this----day of November, 1917, between Lizzie Smith, and N.M. Smith, her husband, of Le Claire, Iowa, as first parties and Hood Land Co., a corporation, as second party, WITNESSETH:-

That whereas heretofore Nels M. Munch and wife did convey to J.P. Porter and Company by deed dated Decmber 31, 1906, and recorded in book "K" of Deeds, page 227, records of Skamania County, Washington, all standing and fallen timber located and being on the North $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ of Section 8, Township 3 North of Range 10 East of the Willamette Meridian, in Skamania County, Washington, together with certain rights-of-way according to the terms of an agreement between said parties dated August 27th 1906 and recorded in Book I of Deeds and Agreements, records of said Skamania County, Washington at page 440 thereof;

And Whereas first parties are now the owners of said described land subject to said timber deed and contract and The Hood Land, Co., the party of the second part therein, is the successor of the said J.P. Porter and Co., in the ownership of said timber and rights under said deed and contract.

NOW THEREFORE, in consideration of the sum of One Hundred (\$100.00) Dollars, cash in hand paid by Hood Land Company, second party herein, to first parties, the receipt whereof is hereby acknowledged, the first parties have extended and by these presents do hereby extend the time for removing the timber and the time for the expiration of the rights-of-way and other privileges granted by said above described timber deed and contract, as same effect said described land, for a period of two years from the dates of the expiration thereof fixed by said deed and contract.
