The Southwest quarter of the Southeast quarter, the East half of the Southwest quarter and the Northwest quarter of the Southwest quarter of Section Twenty-Six (26) in Township No 4 North of Range No 9 East of Willamette Meridian containing One hundred and Sixty (160) acres.

Together with, all and singular, the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and also all her right, title and interest in and to the same, including dower and claim of dower.
