That the grantor in consideration of the sum of ten- - - - - Dollars to it in hand paid by the grantee does hereby remise, release and forever quit claim unto the said grantee, and unto his heirs and assigns, all its right title and interest in and to the following parcels of real estate situated partly in Klickitat County and partly in Skamania County in the State of Washington and described as follows, to-wit:-

All that part of the northwest quarter of the northwest quarter/Section twenty three (23), and the west half of the southwest quarter of section fourteen (14), all in Township three (3) north of range ten (10) east of the Willamette Meridian, lying between a line drawn one hundred (100) feet westerly from and parallel to the west bank of the White Salmon River and a line drawn one hundred (100) feet easterly from and parallel to the east bank of said river as it naturally flows through said lands.
