WIND RIVER LUMBER COMPANY. to FLEISHHACKER.

THIS INDENTURE, made and entered into this 24th day of April, 1912, by and between WIND RIVER LUMBER COMPANY, a corporation, duly organized and existing under and by virtue of the laws of the State of Wisconsin, hereinafter called the grantor, and MORTIMER FLEISHHACKER, of San Francisco, California, hereinafter called the grantee, witnesseth, that: WHEREAS, the grantor herein has full power and authority to convey by warranty deed all the real property hereinafter described, and WHEREAS, the Board of Directors of the grantor herein with the concurrence and approval of the owners and holders of all its subscribed common stock has by resolution authorized and directed this deed to be executed by its president and Secretary under its corporate name and seal; NOW THEREFORE, in consideration of the sum of One Hundred Dollars, lawful money of the United States of America, in hand paid by the grantee, the receipt of which is hereby acknowledged the grantor does hereby grant, bargain, sell and convey unto the said grantee and unto his heirs and assigns, all that certain real property with the appurtenance tenements, hereditaments and privileges situated partly in Klickitat County and partly in Skamania County in the State of Washington and described as follows, to-wit: "A" The southwest quarter of the northeast quarter of Section 3; the east half of the southeast quarter, the northwest quarter of the southeast quarter, and the southeast quarter of the northeast quarter of Section 4; The south half of the southeast quarter, and the northwest quarter of the southeast quarter of Section 8; the east half of lot 1, and the West half of lot 2 and the west half of the southeast quarter of the northwest quarter, and the east half of the Southwest quarter of the northwest quarter of Section 23; all being in township 3 north of range 10 east of the Willamette Meridian. "B" The southeast quarter of the northeast quarter of section 25; the west half of Section 26; and the northeast quarter of the northeast quarter of section 35; all being in Township 5 north of range 10 east of the Willamette Meridian; "C" Lot 2 and the south half of the northeast quarter; the south half of the northwest quarter, the north half of the southeast quarter, the north half of the southwest quarter, the southwest quarter of the southeast quarter, the east half of the southeast quarter of the southwest quarter; the west half of southwest quarter of the southwest quarter; and the west half of the east half of the southwest quarter of section 5; the southeast quarter of the northeast quarter; the east half of the east half of the southwest quarter of the northeast quarter; the northeast quarter of the southeast quarter of section 6;
