O'Brien as Trustees for said Columbia Railroad Company, and as the holders of all of the capital stock of said Columbia Valley Railroad Company, do hereby remise, convey and quitclaim unto the Oregon-Washington Railroad & Navigation Company, an Oregon corporation, all the right, title and interest of said Columbia Valley Railroad Company in and to any and all property held by the said Columbia Valley Railroad Company in the Findley Donation Land Claim, Skamania County, Washington.
