Rominger the party of the first part, and Alice Beitel Rominger the party of the second part: WITNESSETH: That the said party of the first part, for and in consideration of the sum of Ten (\$10.00) Dollars, coin of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents remise, release and forever quit claim unto the said party of the second part, and to her heirs and assigns, the following described tract, lot, or parcel of land, situated, lying and being in the County of Skamania State of Washington, particularly bounded and described as follows, to-wit: All the south half of the southwest quarter of the northeast quarter of Section Twenty one (21) Township three North, Range ten East, Willamette Meridian, containing 20 acres, more or less, saving and excepting a strip of land along the west end of said tract, heretofore reserved for road purposes, said strip being ten feet in width. Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.
