west half of the southeast quarter of the northwest quarter, and theeast half of the south
west quarter of the northwest quarter of Section 23; all being in township 3 north of

"B" The Southeast quarter of the northeast quarter of section 25, the west half of Section 26; and the northeast quarter of the northeast quarter of Section 35; all being in township 5 north of range 10 east of the Willamette Meridian;
