ROMINGER TO ROMINGER.

THIS INDENTURE, Made this 18th day of April, in the year of our Lord One Thousand Nine Hundred and sixteen BETWEEN Alice Beitel Rominger the party of the first part, and Henry V.Rominger the party of the second part.

WITNESSETH: That the said party of the first part for and in consideration of the sum of Ten (\$10.)Dollars, coin of the United States of America, to her in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents, remise, release and forever quit claim unto the said party of the second part, and to his heirs and assigns, the following described tract, lot, or parcel of land, situated , lying and being in the County of Skamania State of Washington, particularly bounded and described as follows, to-wit:

All the south half of the southwest quarter of the northeast quarter of Section twenty one (21), Township three North, Range ten East, Willamette Meridian, containing 20 acres more or less. Saving and excepting a strip of land ten feet inwidth along the west end of said tract heretofore reserved for road purposes.
