RIGHT OF WAY DEED

KNOW ALL MEN BY THESE PRESENTS, That A.C. Sly and Margaret M. Sly his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable consideration, and the sum of One hundred forty and no/100 (\$140.00) Dollars paid them by the County of Skamania the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto said Skamania County, the following described parcel of land, situated in Skamania County, in the State of Washington, to-wit:

Commencing at the south side of Front Street at intersection of Columbia St. River-view Addition to the Town of Stevenson, thence S 34 deg 30' E to the Meander Line of Columbia River, thence N 66 deg 30' E along meander line 61 feet, thence N 34 deg 30' W to the south line of Front Street, thence S 55 deg 30' W. along south line of Front St 60 feet to place of beginning. This strip of land 60 feet in width is for road purposes and is a continuation of Columbia St to the meander line of the Columbia River and Ferry
