## WELCH TO HAFFEY & HOFFMAN

THIS AGREEMENT made and entered into this 19th day of December, 1917, by and between J. D. WELCH and IDA A. WELCH, his wife, of Portland, Multnomah County, State of Oregon, the parties of the first part herein and J. T. HAFFY and CTTO HOFFMAN, of Cape Horn, Skamania County, State of Oregon, the parties of the second part herein WITNESSETH:-

That the said parties of the first hereby and by these presents agree to sell and the said parties of the second part hereby and by these presents agree to purchase, at the agreed and stipulated price and upon the terms and conditions hereinafter set forth, all the merchantable timber both standing and fallen upon the following real estate situate, lying and being in the COUNTY OF SKAMANIA, STATE OF WASHINGTON, and particularly bounded and described as follows, to wit: The South Half of the Northeast Quarter (St of NEt) and the Northeast quarter of the Southeast Quarter (N.E. 4 of S.E. 4) of Section Thirty-four (34), Township Two (2) North of Range Five (5) East of the Willamette Meridian, in accordance with the government survey thereof: That the price for said timber, both standing and fallen, is mutually agreed upon as FIFTEEN HUNDRED DOLLARS (\$1500.00) of which said sum the said parties of the second part have paid the sum of THREE HUNDRED DOLLARS (\$300.00) leaving a balance of \$1200.00 upon said purchase price and which is to be paid at the rate of \$1.50 per M. as the said logs are cut and rafted; that said logs so cut from said premises aforesaid shall be scaled at the mill where sold and the said mill shall furnish, and said second parties shall cause the mill so to do, said first parties with a statement of each raft so sold and scaled? and at said time shall also pay to said first parties, on account of said second parties, the sum of \$1.50 per M. on each M feet of logs so scaled and purchased and the said payment shall be credited on the said balance of \$1200.00 due hereon and until the entire sum is
