THIS INDENTURE WITNESSETH, That Maggie # E. Hamilton and E.C. Hamilton, her husband of Stevenson, Wash. parties of the first part, for and in consideration of the sum of One Dollar and other valuable consideration in lawful money of the United States of America, to them in hand paid by A.J. Pratt of Stevenson, Wash. party of the second part, have GRANTED, BARGAINED AND SOLD, and by these presnets do Grant, Bargain, Sell and Convey unto the said party of the second part and to his heirs and assigns, the following described real property, situate, lying and being ⁱⁿ the County of Skamania State of Washington, to-wit:

Commencing at a po int on the east side of Strawberry road, 180 feet north of the southwest corner of Lot Ten (10) Stevenson Park Addition, according to the offical and duly recorded *plat thereof* in Section 36, Tp. 3 N., Range 7 E., Wil. Mer.. thence east 79 feet more or less to the west side of county road (forty feet wide), thence in a northwesterly direction on the west side of said county road 110 feet more or less, to a point where the west boundary of said 40-foot county road intersects the east boundary of said Strawberry road, thence in a southerly direction on east side of said Strawberry road 100 feet, more or less to the place of beginning. TO HAVE AND TO HOLD the said premises, with all their appurtenances, unto the said party of the second part, and to his heirs and assigns forever; and the said Maggie # E. Hamilton and E. C.
