BOONE and NELLIE BOONE, his wife, in consideration of the sum of Ten (\$10) Dollars to them in hand paid, receipt whereof is hereby acknowledged, do hereby bargain, sell and convey unto E.A. SESSIONS, his heirs, executors, administrators and assigns all our right, title and interest, to-wit, an undivided 3/60 interest in and to the following described lands and mining premises, which lands and mining premises are more specifically described in that certain Mineral Patent heretofore on to-wit, March 3, 1910 issued to E.A. Sessions, to-wit:
