## TELEGRAPH AND TELEPHONE LINES

## PETERSON TO THE UNITED STATES.

KNOW ALL MEN BY THESE PRESENTS, that we Ole Peterson a single man, of the County of Skamania State of Washington, in consideration of One dollars (\$100) to me in hand paid and other good and valuable considerations, the receipt whereof is hereby duly acknowledged, do hereby grant, bargain, sell and convey unto the United States of America, an easement and right-of-way in gross over the following tract or parcel of land, situated, lying and being in the County of Skamania State of Washington, and bounded and particu arrived as follows: S of N W and Lot #4 Sec. 29 and Lot #3 Sec 30 T 7 N R 5 E W.M

The said right-of-way hereby granted is for the construction, maintenance, and full, free and quiet use and enjoyment of one line of trees and poles bearing telephone and telegraph wires and traversing the above-described premises according to the following general course, and direction, to-wit: Entering about the middle of the N boundary of S.E. N W & Sec 29

T 7 N R 5 E running in a southwestenly direction thru the above described premises and leaving about the middle of the W line of Lot #3 Sec 30 T 7 N R 5 E. and to be used for the purpose of communication by telephone and telegraph and other.

This grant shall be effective so long as said easement shall be actually used for the purpose above specified and all rights hereunder shall revert to the owner of the land as soon as the said use thereof shall be abandoned and descontinued.

The grantee shall at all reasonable times have the right to enter for the purpose of construction, repairing, patrolling and removing such telephone and telegraph line, doing as little damage as possible.
