unto the said party of the second part the following real estate in Skamania county, state
of Washington, described as follows, to-wit:

Beginning at apoint 30 feet east and 122 rods and 10 feet north of Southwest corner
of the Northwest quarter of the Southwest quarter of section 21 Township 3 north of Range
8 East of Willamette Meridian, running thence East 58 rods and 13 2/3 feet thence North
19 rods and 14 feet; thence west 58 rods and 13 2/3 feet thence south 19 rods and 14 feet
to place of beginning, containing 7 1/2 acres more or less.
