THIS DEED, Made the twenty eighth day of October, in the year of our lord one
 thousand nine hundred and sixteen, by the NORTHERN PACIFIC RAILWAY COMPANY, a corporation
 of the State of Wisconsin, grantor, to F.A.MULTHAUF, of Portland, in the county of
 Multnomah, and State of Oregon, grantee, WITNESSETH,

WHEREAS, by a contract in writing entered into on the eighth day of April, A.D.
 1913, the grantor contracted to sell and convey to John F.Theda, to whose rights the
 grantee has duly succeeded, for the consideration hereinafter expressed, the
 premises hereinafter described, which contract has been duly performed and the
 grantee has become entitled to a conveyance of the premises.

THEREFORE, the grantor, in consideration of the sum of seven hundred forty six and
 sixty six hundredths (\$746.66) Dollars, unto it paid according to said contract, the
 receipt whereof is acknowledged, grants, bargains, sells and conveys unto the grantee.
