That the purpose and object of said action is to secure judgment against the defendant in the sum of Six Thousand and Forty-eight and 12/100 (\$6048.12) Dollars, with interest thereon at the legal rate from June 1st, 1918, together with costs of suit, and to secure a writ of attachment upon the hereinafter described property.

That the premises and real property affected by and involved in said action is situated in Skamania County, State of Washington, and is described as follows:

"Beginning at a point 1432 feet South and 2322 feet East of the Section corner of sections 16, 17, 20 and 21, Twp. 2 North of Range 7 East of the Willamette Meridian; said point being 40 feet from the S.P. & S. right-of-way, and also at County Road and marked by a 3/4 inch iron pipe or stake and running North 47 deg. and 10' West 1022 feet to a point on State Road No. 8 and marked by 1/2" iron rod; thence South 86 deg. West 635 feet; thence North 45 deg.
