KNOW ALL MEN BY THESE PRESENTS, That we, Alyce Buslach, formerly Alyce Hawkins, in right
of wife, and Philip Buslach, her husban, formerly of Skamania County, Washington, County
of Tillamook and State of Oregon, in consideration of One Thousand (1000) Dollars to us
paid by E. W. Murdock, formerly of Skamania County, Washington, now of The City of
Tacoma, County of Pierce, Washington, the receipt whereof is hereby acknowledged, do
hereby grant, bargain, sell and convey unto said E. W. Murdock and unto his heirs and
assigns, the following described real property, situated in Skamania County, State of
Washington, to-wit:

The southwest quarter of the southeast quarter of section twenty-two (22), in town-
ship two (2) North of Range five (5) East of the Willamette Meridian, containing forty
040) acres, more or less, and being the south 40 acres of the Homestead Claim of the
