ORDER AND DECREE.

This cause came on regularly to be heard before the court above named on the 27th day of February, 1918, in pursuance of notice duly given to the claimant above named, petitioner, County of Skamania, appearing by E.E. Shields, Deputy Prosecuting attorney of said county, and the claimant, Spokane, Portland and Seattle Railway Company, appearing by Omar S. Spencer and Carey and Kerr, its attorneys.

There as thereupon presented a situation in writing signed by the petitioner, County of Skamania, and by the claimant, Spokane, Portland, and Seattle Railway Company, duly filed herein, consenting to the entry of this order and decree:

IT IS NOW FOUND, ORDERED, ADJUDGED AND DECREED that the construction of a public highway over and along the parcels of land described in the petition herein and hereinafter particularly described, is necessary, and that the use and occupation of said parcels of land by the County of Skamania for highway purposes is really a public use, and that the public interest requires the construction of a public highway thereover and that the said parcels of land are required and necessary for such highway purposes.

IT IS FURTHER FOUND, ADJUDGED AND DECREED that the parcels of land hereinafter described and all thereof are included within the survey heretofore made by the State of Washington under authority of law and by Chapter 151 of the Laws of Washington for the year 1907, adopted and declared to be a State Road to be known as "STATE ROAD NO. 8. of the COLUMBIA RIVER ROAD". and thereafter by Chapter 65 of the Laws of Washington for the year 1913, declared to be and classified as a "secondary road".

IT IS FURTHER, ADJUDGED AND DECREED that that certain appropriation of the sum of \$54,950 by Chapter 53 of the Laws of Washington for the year 1915 for the construction of that portion of "State Road No. 8" situated between the towns known as Butler and Cook of Skamania and that ~~portion~~ certain appropriation of the sum of \$15,955.19 Chapter by Chapter 113 of the Laws of the State of Washington for the year 1915 for the construction of that portion of "State Road No. 8." between the said appropriations, were and are intended for and applicable in part to the construction of that portion of said "State Road No. 8." located upon the parcels of land hereinafter particularly described and that the officers of the State of Washington intend to apply said money so appropriated or so much thereof as may be required toward the construction of that portion of said "State Road No. 8." located between the said towns of Butler for the construction of said road upon the parcels of land hereinafter particularly described, the same, being situated between said towns of Butler and Cook.
