THIS AGREEMENT, made the Sixteenth day of July, 1918, between FRED J. PYE, of Tillamook City, in the County of Tillamook and State of Oregon, hereinafter called the seller, and JOHN J. MACKEY, of Cape Horn, in the County of Skamania and State of Washington, hereinafter called the buyer,

WITNESSETH: that the seller, in consideration of the sum of One Dollar to him in hand paid by the buyer, the receipt whereof is hereby acknowledged, hath agreed and hereby doth agree to assign to the buyer, by a good and sufficient assignment in writing, on or before the First day of July, 1920, all that certain bond or obligation, bearing date the 6th day of November, 1911, and recorded on November 19th, 1912, in the Office of the County Auditor of the County of Skamania in the State of Washington, in Book C of Deeds at Page 133, in which bond the seller is named as the Obligee. a copy of said bond is hereto attached, marked "EXHIBIT A".

THIS AGREEMENT IS MADE UPON THE EXPRESS CONDITION, however, that the buyer shall pay to the seller, at Tillamook City, Oregon, the sum of Eleven hundred and ten Dollars, in installments as follows, time being of the essence of said payments:

Two hundred Dollars at the time of the delivery of this agreement,

Two hundred Dollars on or before the First day of December, 1918.

Three hundred Dollars on or before the First day of June, 1919, and

Four hundred and ten Dollars on or before the First day of June, 1920;
