D E C R E E.

The Court having heard the evidence in this case and made and entered its Findings of Fact and Conclusions of Law wherein and whereby it was found and determined that the plaintiff is entitled to a decree of divorce from the defendant.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the plaintiff, J. O. Strass, is hereby absolutely divorced from the defendant and the bonds of matrimony heretofore existing between the plaintiff and defendant are hereby forever dissolved.

IT IS FURTHER ORDERED AND ADJUDGED that the plaintiff, J. O. Strass is the sole and separate owner of the following described real estate situated in Skamania County, Washington, to-wit:

Beginning at a point four hundred thirty feet east and twenty feet south of the north west corner of the South-east quarter of the South-east Quarter of Section Twenty, Township Three North of Range Eight East of the Willamette Meridian, running thence South West Two Hundred feet, thence East two Hundred feet thence North Two Hundred feet, thence West Two Hundred Feet to the place of Beginning.

IT IS FURTHER ORDERED AND ADJUDGED that both parties to this action are hereby prohibited from inter-marrying with any third person for a period of six months from and after the date of the entry of this decree.
