White Salmon River now possessed by the Northwestern Electric Company, the White Salmon Boom & Improvement Company or the Frost Improvement Company.

- 3. That this easement and any flume or pipe line constructed pursuant to this grant shall in no wise interfere with the construction or maintenance of any pele lines or of any roads that the Northwestern Electric Company, may in the future construct or permit to be constructed across the easement hereby granted.
- 4. That this grant shall become effective only in case the proposed flume or pipe line is actually installed and shall then be effective only for such length of time as said flume or pipe line is used, and in no event shall this grant extend for a longer period than twenty years from the date hereof.
