That the said Jennie Marion Salling Kanouse left surviving her a daughter and only child, Marion Salling Kanouse, the daughter of petitioner, and that said Marion Salling <sup>Kanouse</sup> and the petitioner Harry W. Kanouse are the only heirs of the said Jennie Marion Salling Kanouse, as will more fully appear from the affidavit of petitioner attached hereto and made a part hereof. That said daughter of petitioner, Marion Salling Kanouse is now sixteen years of age.

IV.

That the Michigan Trust Company is a corporation organized and existing under and by virtue of the laws of the State of Michigan with its office and principal place of business at Grand Rapids, Kent County, Michigan, and is a citizen of said state. That said Michigan Trust Company is authorized by its Articles of Incorporation to accept and administer trusts, to act as administrator and guardian, and to do generally the business of a trust company. That it is also authorized to accept and administer trusts, to act as administrator and guardian, and to do generally the business of a trust company in the State of Washington, having duly complied with all the provisions of the laws of the State of Washington relating to the transaction of business by it as a foreign corporation. That said Michigan Trust Company is the guardian of the estate of Marion Salling Kanouse in the State of Michigan by appointment of the Probate Court of the County of Wayne, State of Michigan, and is a proper and suitable person to act as the administrator of the estate of said deceased herein.

V.

That said petitioner, as the widower of said Jennie Marion Salling Kanouse has the right to administer upon the estate of said deceased and to appoint the administrator of said estate, and that he hereby nominates and requests the appointment of said Michigan Trust Company, as said administrator.

WHEREFORE, your petitioner prays that letters of administration of the estate of said deceased be issued to the said Michigan Trust Company, and your petitioner will ever pray.
