All the cottonwood timber and trees standing and being upon the said premises, heretofore granted to Western Transportation & Towing Company, a corporation, by deed dated January 17th, 1908, and recorded in Book L of Deeds, records of Skamania County, Washington; on page 4.

Subject also to a certain lease of shore land and water front for a fish wheel dated September 16th, 1899 and recorded in Book 1 Agreements and Leases page 177, records of Skamania County, Washington, as extended by endorsement dated August 15th 1918 and recorded on page 426 of Book 2 Agreements and Leases. Granting, however, to the said parties of the second part the rents, profit income and rights under said lease and agreement accruing to said parties of the first part therefrom.
