IRPIGATION DISTRICT, an irrigation district of Skamania County, Washington, an easement over and through a right of way extending across the grantors land in Section fourteen (14) Township three (3), North, Range Ten (10) East of Willamette Meridian, and along the West side of the White Salmon river from the points and along the courses and distances as follows, to-wit: Beginning at a point on the west bank of the White Salmon river, in the southwest quarter $(SW_{\frac{1}{4}})$ of the southwest quarter $(SW_{\frac{1}{4}})$ of said Section 14, at a point where was formerly located the West end of the "splash" dam used for logging purposes on said river, a portion of the West end of which said dam is still located there; thence following the courses and distances as follows, to-wit:
