CALLIGAN et al to NORTHWESTERN ELECTRIC CO.

In consideration of One Dollar, the receipt whereof is hereby acknowledged, Wilbur H. Galligan and Margaret L. Galligan, his wife, grant to NORTHWESTERN ELECTRIC COMPANY, a perpetual right-of-way in and over the following described real property, situated in the County of Skamania, State of Washington, to-wit:

Beginning at a point on the south line of the N.W. 1/4 of Sec. 30, T. 3 N. R. 10 E.W.M. 60 feet, more or less, east of the S.W. corner of said N.W. 1/4; thence north 36 degrees point; thence north 48 degrees 30' east, 374 feet, more or less, to a 20' east, 1060 feet, more or less, to a pole in the present transmission line as constructed, marked $\frac{80}{A}$

For the purpose of erecting, maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.

The second transmission line shall be constructed parallel to the first line and not to exceed fifty feet from it and in a northerly direction.

Grantors reserve to themselves, their heirs, assigns and legal representatives, the entire use of the land included within said right of way for all purposes which do not
