HARRIET A. TURNER to PETER PETERSON
WARRANTY DEED

THE GRANTOR Harriet A. Turner, a widow, for and in consideration of One Dollar in hand paid, CONVEYS AND WARRANTS to Peter Peterson, a single man grantee the following described real estate, situated in the County of Skamania State of Washington:

All of lot Nine (9) and all that portion of Lot Ten (10) lying and being North of the creek known as Wolf Creek, all in Section Twenty-four (24) Township Three North of Range Seven and One half (7½) East of the Willamette Meridian.

TO HAVE AND TO HOLD THE SAME unto the said grantee, his heirs and assigns forever.

This deed is made for the purpose of correcting error in that certain deed made by the said grantor herein to the said grantee, bearing date July 7th, 1913, recorded July 7th 1913 in Book 0 of Deeds Page 355, and the said grantor does hereby covenant and agree to and with the said grantee, that the same is free from incumbrances except such as may have been incurred by the said grantee, and that she will, and her heirs, administrators and executors shall, forever WARRANT AND DEFEND the title thereto, except as to claims accruing through the said grantee.

These presents shall in no wise affect rights in or to the property herein described accruing to the said grantee through the former deed above mentioned.
