

CHAINS TO THE POINT OF BEGINNING, THE TIDELANDS DESCRIBED IN THE FOUR LAST ABOVE DESCRIPTIONS HAVING A TOTAL FRONTAGE OF 45.80 LINEAL CHAINS, MEASURED ALONG THE MEANDER LINE, ACCORDING TO A CERTIFIED COPY OF THE GOVERNMENT FIELD NOTES OF THE SURVEY THEREOF ON FILE IN THE OFFICE OF THE COMMISSIONER OF PUBLIC LANDS AT OLYMPIA, WASHINGTON.

PARCEL No. 4.

ALSO ALL TIDE LAND OF THE THIRD CLASS, FORMERLY OWNED BY THE STATE OF WASHINGTON, SITUATE IN FRONT OF, ABUTTING UPON AND ADJACENT TO LOT ONE (1), OF SECTION 28, AND LOT TWO (2), OF SEC. 27, TWP. 9 N. RG. 6 WEST W.M.; THE MEANDER LINE OF SAID LOTS BORDERING ON SAID TIDE LAND BEING DESCRIBED ACCORDING TO THE U. S. GOVERNMENT FIELD NOTES AS FOLLOWS: LOT 2, SEC. 27, TWP. 9 N. RG. 6 WEST; BEGINNING AT A POINT ON THE U. S. GOVERNMENT MEANDER LINE WHERE THE LINE BETWEEN LOTS 1 AND 2, OF SAID SECTION 27 WOULD INTERSECT THE SAME; THENCE ALONG THE MEANDER LINE IN FRONT OF LOT 2 AS FOLLOWS: N. 85° W., 16.71 CHAINS; N. 36. W., 5.20 CHAINS TO THE MEANDER CORNER TO FRACTIONAL SECTIONS 27 AND 28 AFORESAID; THENCE IN FRONT OF LOT 1 AFORESAID, N. 35 DEG. W., 12.00 CHAINS TO THE MOUTH OF A SLOUGH 187 LINKS WIDE, WHICH COMES FROM THE NORTH; THENCE WEST 2 CHAINS; THENCE N. 72° 15' W., 17.00 CHAINS TO THE MEANDER CORNER TO FRACTIONAL SECTIONS 21 AND 28, SAME TOWNSHIP AND RANGE, WHICH IS 25.00 CHAINS WEST (VAR. 22° 30' E.) OF THE CORNER TO SECTIONS 21, 22, 27 AND 28, SAID TWP. AND RANGE, HAVING A TOTAL FRONTAGE MEASURED ON THE MEANDER LINE OF SAID LOTS 1 AND 2, OF 52.91 LINEAL CHAINS.

PARCEL No. 5.

ALL TIDE LANDS OF THE SECOND CLASS, FORMERLY OWNED BY THE STATE OF WASHINGTON, LYING BETWEEN THE LINE OF MEAN LOW TIDE AND THE LINE OF EXTREME LOW TIDE AND IN FRONT OF LOT ONE (1), SECTION FIFTEEN (15), TOWNSHIP NINE (9) NORTH, RANGE EIGHT (8) WEST W.M., WITH A FRONTAGE OF 20.93 LINEAL CHAINS, MORE OR LESS, MEASURED ALONG THE MEANDER LINE, ACCORDING TO A CERTIFIED COPY OF THE GOVERNMENT FIELD NOTES OF THE SURVEY THEREOF ON FILE IN THE OFFICE OF THE COMMISSIONER OF PUBLIC LANDS AT OLYMPIA, WASHINGTON.

PARCEL No. 6.

LOT ONE (1) OF SECTION FIFTEEN (15), AND THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ) OF SECTION TEN (10), TOWNSHIP NINE (9) NORTH, RANGE EIGHT (8) WEST OF THE WILLAMETTE MERIDIAN, AND TIDELANDS FRONTING AND ABUTTING ON SAID LOT 1.

PARCEL No. 7.

NORTHEAST QUARTER OF THE NORTHWEST QUARTER (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ) AND LOTS 1, 2, 3 AND 4, OF SECTION 24, TOWNSHIP 8 NORTH, RANGE 5 WEST OF THE WILLAMETTE MERIDIAN, CONTAINING 158 ACRES.

PARCEL No. 8.

THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) OF SECTION EIGHTEEN (18), IN TOWNSHIP EIGHT (8) NORTH OF RANGE FOUR (4) WEST OF THE WILLAMETTE MERIDIAN, CONTAINING 31 ACRES.

PARCEL No. 9.

THAT CERTAIN TRACT OR PIECE OF LAND WHICH MAY BE DESCRIBED AS FOLLOWS: COMMENCING AT A STAKE SET IN A MOUND OF STONES ON THE NORTHERLY BANK OF THE COLUMBIA RIVER AT A POINT FIVE HUNDRED (500) FEET SOUTHWESTERLY FROM THE DOCK AND BUILDINGS
